1. Identity of the Data Controller

Ardoz is the data controller within the meaning of Article 4(7) of the GDPR for the processing of personal data as described in this privacy statement.

2. Scope

This privacy statement applies to:

- Visitors to the Ardoz website
- Individuals who contact us via email or contact forms
- Contact persons of (potential) business relations

Ardoz focuses exclusively on business-to-business (B2B) services. The website is not intended for consumers or minors.

3. Which personal data do we process?

Ardoz processes only the personal data necessary for its business activities and website functionality.

3.1 Data provided by you

When you contact us (e.g., via email or a contact form), we may process the following data:

- First and last name
- Company name
- Telephone number
- Email address
- Content of your message

3.2 Technical data via the website

When visiting our website, certain technical data may be processed automatically, such as:

- IP address
- Browser and device data
- Date, time, and duration of the visit

- Pages visited

This data is processed for the purposes of website security, technical management and—where applicable—statistical analysis.

4. Purposes and Legal Grounds for Processing

Ardoz processes personal data exclusively based on the legal grounds set forth in Article 6 of the GDPR.

Execution of an agreement: If you contact us regarding a potential collaboration, quotation, or business relationship, we process your data for:

- Responding to your inquiry
- Issuing quotations
- Entering into and executing an agreement

Legitimate interest: We process personal data based on our legitimate interest for:

- Maintaining business relationships
- Securing and optimizing our website

5. Retention Periods

Personal data will not be kept longer than is necessary for the purposes of the processing.

6. Disclosure to Third Parties

Personal data is only provided to third parties if this is necessary for the execution of the agreement or to comply with a legal obligation. Personal data is **not** sold to third parties.

7. Transfer Outside the European Economic Area (EEA)

If personal data is processed outside the European Economic Area, this will be done exclusively in compliance with Chapter V of the GDPR and with appropriate safeguards in place.

8. Security of Personal Data

Ardoz takes appropriate technical and organizational measures to protect personal data against loss or unlawful processing. These measures include:

- Secure SSL connections
- Access restrictions
- Secure IT environment
- Regular updates and security protocols

9. Rights of Data Subjects

To the extent applicable by law, you have the right to:

- Access your personal data
- Rectification of inaccurate data
- Erasure of data (right to be forgotten)
- Restriction of processing
- Data portability
- Objection to processing
